ORDINANCE NO. 90

ORDINANCE ENFORCEMENT OFFICER ORDINANCE

An Ordinance to establish the office of Ordinance Enforcement Officer; to prescribe the duties of said office; to authorize the Township Board to appoint any person or persons to said office; and to amend any Ordinances of Superior Charter Township which conflict with the provisions hereof.

THE CHARIER TOWNSHIP OF SUPERIOR, WASHTENAW COUNTY, MICHIGAN ORDAINS:

Section 90.01 – <u>Ordinance Enforcement Officer</u> - There is hereby established the office of Ordinance Enforcement Officer within the Charter Township of Superior, Washtenaw County, Michigan.

Section 90.02 – <u>Appointment -</u> The Township Board of Superior is hereby authorized by resolution, at any regular meeting of said Board, to appoint any person or persons to the office of Ordinance Enforcement Officer for such term or term as may be designated in said resolution. Said Board may further, by resolution, remove any person from said office, in the discretion of said board.

Section 90.03 – <u>Duties</u> - The Ordinance Enforcement Officer is hereby authorized to enforce all Ordinances of the Township of Superior, whether heretofore or hereafter enacted, and whether such Ordinances specifically designate a different official to enforce the same or do not designate any particular enforcing officer. Where a particular officer is so designated in any such Ordinance, the authority of the Ordinance Enforcement Officer to enforce the same shall be in addition and supplementary to the authority granted to such other specific officer. The authority of such Ordinance Enforcement Officer shall also be in addition and supplementary to the authority vested in the 'Township Supervisor by state statute. The Ordinance enforcing authority of the Township Supervisor and the other. officer specifically designated in any Township Ordinance shall continue in full force and effect and shall in no way be diminished or impaired by the terms of this Ordinance.

Section 90.04 – <u>Definitions</u> - The Ordinance enforcement duties herein authorized shall include, among other, the following: Investigation of Ordinance violations; serving notice of violations; serving appearance tickets as authorized under Chapter IV of Public Act 175 ()f 1927, as amended; appearance in court or other judicial proceedings to assist in the prosecution of Ordinance violators, and such other Ordinance-enforcing duties as may be delegated by the Township Supervisor or assigned by the township attorney.

Section 90.05 – <u>Saving Clause</u> - The provisions of this Ordinance are hereby declared to be severable and the invalidation of any one or more of the same by any judicial determination or statutory or constitutional provision shall not invalidate the remainder of said provisions or Ordinance.

Section $90.06 - \underline{\text{Effective Date}}$ - This Ordinance shall take immediate effect. All Ordinances of the Township heretofore or hereafter adopted shall hereafter be supplemented by the terms of this Ordinance.
